CJRTC will provide a Main Course, we ask that everyone brings a side dish or dessert to share with the group.

*** Note, All racing terriers, including puppies must be muzzled.*** Only closed end muzzles are allowed. No Mikki or figure eight muzzles*** Please no brightly colored basket muzzles

All puppies must be current on their vaccinations and no puppies under 3 months of age will be allowed at the trial. No Exceptions. No puppy sales at trial site. No puppies under 3 months of age in RV's. If you have young puppies, please bring a Stud Certificate to verify age. This will be strictly enforced. You will be asked to leave and no refunds will be given.

There will be no food service available at the park. There are many fast food restaurants nearby.

REFUNDS for classes will be given ONLY in cases of accident or illness of a terrier or owner, or for bitches in season. Situations must be documented in writing. Refunds provided by mail within 14 days following the trial.

For this event, hurdles will be <u>LOW</u> for <u>ALL</u> age groups. Dogs *MAY* enter both the maiden class and their regular class in racing ONLY.

Camping

Camping is available at the trial site for \$25 per night. Most camp site have electric and water. First come, first serve. 50 amp services available so be prepared with adaptors.

Directions To The Trial Site

From I - 85 South & North - Take I-85 north or south to Exit 17 which is the Highway 321 exit. Turn left onto 321 north. Travel two miles and you will come to the Dallas/Cherryville exit. Gaston College will be on your left. You will need to move to the far right lane, go under the bridge and take the Cherryville side of the exit. Turn right onto Hwy 279 west and follow Final Directions below.

From I - 40 West- Traveling West on I-40, take exit 126 in Hickory. Turn left at the stoplight onto McDonald Pky. Travel through all stoplights, road turns to two lanes. Follow this road until you come to the Hwy 321 entrance ramp. Take the Hwy 321 south entrance. Continue traveling south on Hwy 321 to the Dallas/Cherryville exit. Turn right at the stoplight onto Hwy 279 West and follow Final Directions below.

From I - 40 East -Traveling East on I-40, take exit 123 on the west side of Hickory to Hwy 321 south. Follow Hwy 321 south to the Dallas/Cherryville exit. Turn right at the stop sign onto Hwy 279 West and follow Final Directions below.

Final Directions - Traveling west on Hwy 279, move to left lane and travel through all stoplights and past fast food restaurants. The Gaston County Citizens Resource Center is on left. Turn left into the drive on the far side of the Center. We will have signs posted directing everyone where to go.
